De Premier Spa Agreement

IMPORTANT - PLEASE READ CAREFULLY

Terms and Conditions for the De Premier Spa gift certificate, service and products

This Agreement ("Agreement") outlines the terms and conditions for the services, spa packages, series, gift certificate and products provided by Center for Aesthetics and Wellness Spa ("De Premier Spa") Houston, TX 77079. By purchasing or redeeming the Gift, you agree to be bound by the terms and conditions contained in this Agreement. "You" and "your" means the person or persons who have purchased the service, gift certificate or product and/or the person or persons who have redeemed them. "We," "us," and "our" mean spa, our successors, affiliates or assignees. "Redemption" means the submission of instructions through the De Premier Spa website, www.depremierspa.com ("Website") for the purchase and redemption. By purchasing or redeeming a gift certificate or service, you agree to the terms and conditions set forth in this Agreement.

Spa Conduct/Etiquette

Please turn off all cell-phones or electronic devices upon arrival in our spa/

treatment areas and keep voice levels to a minimum, as other treatments may be in progress.

Reservations

Advanced booking prior to your arrival is recommended to secure your preferred date and time of treatment. A credit card number is required at the time of booking for a confirmed appointment. Please arrive 10-minutes prior to your scheduled start time. Late arrivals will only receive the remainder of their scheduled session.

Gift Certificate/Service Purchase

When you purchase a gift certificate, you authorize us to make an electronic transfer from your desired payment account you provided, such as a debit or credit card. This purchase includes the desired amount of the gift certificate, plus any purchase fees associated with the purchase. In order to purchase a gift, you may be asked to provide your credit card information, billing address, mobile number and email address. An authorization will be placed on your card for the total price of the gift certificate/service to ensure that you have sufficient funds available to cover the transaction. Pending a review of the transaction, your card will be charged the authorized amount. You authorize us to resubmit any charge that fails, is charged back or otherwise reversed.

Gift Certificate/Service Delivery

Prior to completing the purchase, you will select how you want to notify the recipient about the gift certificate/service. Some delivery methods require that the purchaser take action in order for the recipient to be notified about the gift certificate/service, such as if the purchaser elects to receive a printable PDF that's the purchaser will deliver to the recipient. Other delivery methods are facilitated by De Premier Spa, such as email delivery, but delivery is not guaranteed. It's your responsibility to confirm with the recipient that they have received notification of the gift certificate/service. Notification of the gift certificate will include a link or a secure access code that will be necessary to redeem the gift certificate/service.

Gifting of De Premier Spa Gift Certificate/Service

Gift Certificate/Service Redemtion

To redeem a gift certificate/service, you must have a De Premier Spa account. When you create an account we collect all of the information listed above. Note that we may share this information with the individual or entity who gave you the gift certificate/service.

Your Representation and Warranties

By purchasing or redeeming the Gift, you represent and warrant to us that: (i) you are at least 18 years of age (or older if you reside in a state where the majority age is older); (ii) you are a U.S. citizen or legal alien residing in the United States or the District of Columbia; (iii) the personal information that you provide to us in connection with the gift certificate is true, correct and complete; (iv) you received a copy of this Agreement and agree to be bound by and to comply with its terms.

Cancellation Policy

Kindly provide us with a 24-hour cancellation notice for your appointment. Rescheduling of appointments is subject to availability. Cancellations or rescheduling require 24-hour notice for any singular appointment or service. Canceling multiple services, packages, or more require 48-hour notice. Any cancellation with less than the required time may incur a 50% cancellation fee. A full fee will be imposed for a "no-show".

Refund Policy

Treatment services, packages and gift certificates are no cash or credit card refund, non-transferable and non-exchangeable, and cannot be used towards internet product or service purchases. The spa reserves the right to offer and recommend

alternative spa treatments if the ones requested are not available. Under no circumstances will refunds be issued for services rendered. We would offer to fix any issues instead. Gift certificates purchased via bulk order or API may be non-refundable.

Special Consideration

Please inform your therapists of any medical conditions, pregnancy or medications you are taking, or any notable changes since your last treatment.

Our Gift Cards/ Gift Certificates does not expire. Present your card/gift certificate at the time of check-in for service. Gift cards/gift certificates have no cash value, are non-refundable and non-transferable.

Center for Aesthetics and Wellness Spa (De Premier Spa) is not responsible for lost gift cards/gift certificate. Gift cards/gift certificates will be debited the service amount for any no-show appointments.

Retail Return Policy

How We Use Personal Information

Personal Information Disclosure

De Premier Spa will not rent or sell your Personal Information to others. If we do, such third parties' use of your Personal Information will be bound by terms at least as restrictive as this Privacy Policy. We may store personal information in locations outside the direct control of De Premier Spa (for example, on servers or databases co-located with hosting providers).

Our service may require that we share your personal information with third parties, including but not limited to:

Service providers who provide us a range of essential operational services including fraud prevention, transaction processing,

collections, direct marketing, and managed technology services. Our contracts dictate that these service providers only use your information in connection with the services they perform for us and not for their own benefit.

Financial institutions that allow us to offer you payment processing services, and partner with us to develop new offerings for you and other De Premier Spa clients.

Fellow De Premier Spa clients who you may send or who may send you gifts.

Law enforcement authorities or government representatives who may require us to share information in order to comply with court order and other legal mandates, or when we believe that disclosure is necessary to report suspicious activities, prevent physical harm, financial loss, or violations of our agreements and policies.

Other third parties, subject to your prior consent or direction.

As we develop our business, we may buy or sell assets or business offerings. Customer, member, transaction, email, and visitor information is generally one of the transferred business assets in these types of transactions. We may also transfer such information in the course of corporate divestitures, mergers, or dissolution.

From time to time, we may run contests, special offers, or other events or activities ("Events") on the Service together with third party partners. If you provide information to such third parties, you give them permission to use it for the purpose of that Event and any other use that you approve. We cannot control third parties' use of your information. If you do not want your information to be collected by or shared with a third party, you can choose not to participate in these Events.

Except as otherwise described in this Privacy Policy, De Premier Spa

will not disclose Personal Information to any third party unless required to do so by law or subpoena or if we believe that such action is necessary to (i) conform to the law, comply with legal process served on us or our affiliates, or investigate, prevent, or take action regarding suspected or actual illegal activities; (ii) to enforce our Terms and Conditions and related agreements, take precautions against liability, to investigate and defend ourselves against any third party claims or allegations, to assist government enforcement agencies, or to protect the security or integrity of our site; and (iii) to exercise or protect the rights, property, or personal safety of De Premier Spa, our users or others.

We may share aggregated demographic and statistical information with our other partners. This is not linked to any personal information that can identify any individual person.

Personal Information Compromise

In the event that personal information is compromised as a result of a breach of security, De Premier Spa will promptly notify those persons whose personal information has been compromised in accordance with the notification procedures set forth in this Privacy Policy or as otherwise required by applicable law.
